Variance Requirement	Approval Authority
Shell employee or contractor, or industry guest – first round-trip variance	Destination Operations Manager, Wells Operations Team Lead, or P&T Project Manager
Shell employee or contractor, or industry guest – subsequent round-trip variances	Asset Manager (Production), Wells Operations Manager (Drill Ships), or Project General Manager (P&T Support)
VIPs, Media, Government representatives – any flight	Asset Manager (Production), Wells Operations Manager (Drill Ships), or Project General Manager (P&T Support)
VIPs, Media, Government representatives – essential control not in place such as more than 50% untrained passengers in cabin	VP Production VP Wells Deepwater
